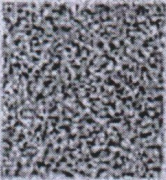

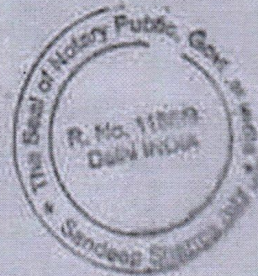


4) We ensure that no commercial activity will take place within the school campus other than schooling as permitted by the board

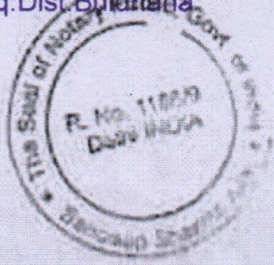
